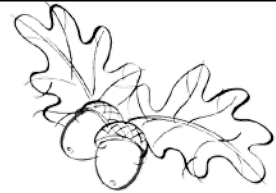

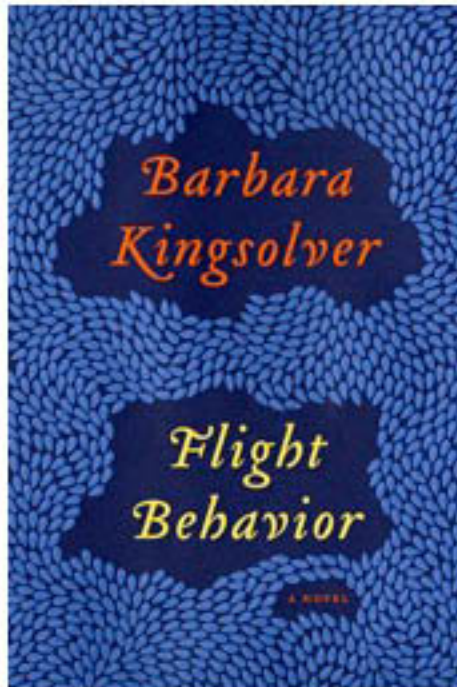

# League of Women Voters - Janesville Membership Meeting September 18, 2013

Our guest speaker was Andrea Kaminski, Executive Director and Lobbyist for Wisconsin League of Women Voters. She gave us an update on the status of the Voter ID law - the investigation is not turning up any kind of fraud that voter ID would address. .00009% of all votes were cast illegally. Those were done by felons still on paper, one couple thought they should be able to vote in the two counties they owned property. The bill would affect mostly people of color and the elderly. The Birth Certificate issue, the cost involved in obtaining a copy, more of a burden on women - with their name changes from marriage, divorce, etc.

The League of Women Voters, one of four, to bring law suites in the State. We got a favorable ruling at the first level which was over turned by the appeals court, moved onto the supreme court. NAACP's suit is seeking evidence of people of color being disenfranchise. There was a lot of confusion during all of the elections in early 2012 with the proof of residence. Some observers of the elections were very aggressive. Confusion of how the election official could handle that problem. But by the Presidential election it was all different. We had 300 league observers in over 400 polling places. There was less confusion on same day registration, handling of observers, etc. The GAB did more training, and had clearer guidelines on identification, and what the election officials could do with the observers.

We have a right to vote in our state constitution. We



have a high voter turn out, we have local election official that are skilled, friendly and willing to help their constituents vote. These are part of the differences that we have that other states do not have. Just having the GAB is unique.

The board is made up of former judges, who really care about voting in Wisconsin. Any future reforms should address really documented issues (not like the Voter ID) retain same day registration, continue to improve the training of election officials, allow a wider array of residency requirements. Continuous on-line registration, allow municipalities to handle absentee voting, off site voting, enhance voter education.

What are we seeing: one bill has on-line registration, seeing bills that limit the availability of registration, ones that make it impossible to vote, one in which if there is a poll work error to remove ballots of random voters; it challenges the registering of voters (not at the time of registration but afterward).

How the GAB is formulated right now, it is made up of 6 former judges who go through the candidate nomination board which gives their name to the governor, a bill in the legislature would double the number of candidates thus flooding the governor with candidates and making it easier to stack the GAB.

**Redistricting-** Senator Cullen's bill would have the legislative reference bureau draw the lines. This last redistricting was very secretive, and expensive! We have to not let this continue. We need to give it a public hearing.

## **Questions and Answers:**

**Question 1:** Will the GAB move to audit voting? Is that a good idea? **Answer:** We have really discussed it. Justice Kennedy said maybe it is a good idea.

**Question 2:** What are the other issues? **Answer 2:** Mining bill, medicaid, vouchers.

**Question 3:** What about open records? **Answer 3:** One assembly person says that they are in a continued in session and so are exempt for any open records law suit. No matter what the issue.

## Leaguers Initiate Update of County Parks Position

Beloit and Janesville Leagues are reviewing our position on Rock County parks. Our current position is ten years old and contains some outdated language.

Beloit Mmembers Dave Dobson and Joyce Schoenfield met with Janesville members Carolyn Brandeen and Neil Deupree. They briefly reviewed the 2002 Beloit/Janesville LWV position on county parks and Rock County's 2009-2014 Parks Outdoor Recreation and Open Space Plan (POROS) posted on the county's website.

Since the current POROS plan is for 3009-3014, and another five year plan will be created for County Board adoption and necessary budgeting, this is an especially good time to update the League's position. (The Janesville League adopted the review at their Annual Meeting and the Beloit League is continuing our review of all our local positions.

As part of the initial information gathering process Neil checked with Colin Byrnes in Rock County's Planing and Development Agency and Dave and Carolyn met with Parks Department Director Lori Williams. The committee is tentatively meeting in January.

Meanwhile, committee members will be learning more about amenities in our county parks, the park plan, and status of funding and planning.

This will be an interesting study with local impact. Several members have indicated an interest in being apart of the process. Or next committee get together will be in November. We'd like to have you join us. Just contact Carolyn or Neil.

## **The current position of the League of Women Voters of Janesville**

### **SUPPORT FOR HISTORIC AND NEIGHBORHOOD PRESERVATION**

October, 1979; Revised April, 1988

The League of Women Voters of Janesville feels that preservation is important to the future of Janesville. The City has definite role in preservation. Preservation should be integrated into the overall process of planning for community development. Plans for streets, schools, and other community facilities should be evaluated in terms of their effect on the neighborhood and historic resources.

The City of Janesville is an entitlement community under the federal Community Development Block Grant Program. These funds should be used to support neighborhood goals, for rehabilitation that is appropriate to the building, and along with private involvement to undertake a survey of the historic resources of the city. Alternative housing should be made available for those who might be displaced by rehabilitation activities. In addition, re-use of historic building should be a major consideration in all redevelopment projects.

The League feels that the City of Janesville should adopt an historic district ordinance and appoint an historic preservation commission. This would allow interested property owners to take advantage of the various tax incentives for preservation. The neighborhood should be involved in the definition of historic boundaries.

The city should also:

1. publicize tax incentives which are available;
2. encourage property owners to find alternatives to the destruction of historic buildings;
3. re-evaluate existing city ordinances for their affect on historic structures;
4. require that new construction in historic areas be compatible with the area;
5. require that renovation of historic structures and those in historic districts be in keeping with the style of the buildings;
6. allow variances to the ordinances to encourage the re-use of historic buildings;
7. make sure that the assessment of historic properties reflects their lower fair market value because of their lower potential for development;
8. enforce the existing building codes so that historic structures do not deteriorate because of neglect.

# A look at Multicultural Diversity and the Janesville School System

On April 5, 1993 the Board of Directors of the Janesville League of Women Voters approved a position on multicultural diversity and the Janesville School System which grew out of a study on the same topic. The position was adopted at the May, 1993 meeting of the LWV. It was decided that it is time to study the position again and see if an update is needed.

Debbie Fisher and Ted Kinnaman have conducted two interviews to date. They interviewed the current president of the School Board, Greg Ardrey and two staff from the Curriculum Department of the Janesville School District, Dr. Kim Erhardt and Dr. Julie DeCook.

A couple of highlights of what has been learned include that the District has 10,308 students and 23% of them are minority students: Asian, 2%; African American 5%; Hispanic, 11%; bi-racial 5%.

Every Tuesday morning there is a required session of professional development for all teaching staff. A portion of the development is titled the "Platinum Plan". This plan has three components:

White Privilege or Unconscious Bias

Poverty

Culturally Responsive Teaching or Culturally Relevant Curriculum
