# Status of Candidate Forums

To provide an update on Candidate Forums for the November 2022 General Election, I thought I would share with you the email message I sent to Tim Bremel of WCLO radio on September 14 in response to his interest in collaborating with the League of Women Voters:

Hi Tim,

I'm sorry that it has taken me so long to get back to you with an update. Frankly, after investing a lot of time and effort into the process of scheduling candidate forums for the November general elections, we are disappointed in what we've been able to accomplish.

Immediately following the August primary elections, a committee representing the LWV-Janesville, LWV-Beloit, LWV-Whitewater Area, LWV-Dane County, and the NAACP of Beloit began work to set up candidate forums for EIGHT county-wide and state legislative races:

Rock County Sheriff  
Senate Districts 11 and 15  
Assembly Districts 31, 33, 43, 44, and 45

Because we have been unable to obtain the cooperation of the candidates of both parties, we will be able to hold only THREE of the EIGHT forums:

**Rock County Sheriff:** Fell (D) vs. Keller (I) on Wednesday September 28, 6:00-7:30 pm, Hedberg Public Library, Janesville (broadcast live, live-streamed on YouTube, and recorded by JATV)

**Assembly District 33:** Vruwink (D) vs. Johnson (R) on Thursday, October 6, 6:00-7:30 pm, Ft. Atkinson Library.

**Assembly District 45:** Anderson (D) vs. Klett (R) on Wednesday, October 12, 6:00-7:30 pm, School District of Beloit School Board Room

**We have had to cancel the other five forums because only one of the candidates running for office in each of those races has agreed to participate**

The failure of candidates to participate in League of Women Voters forums deprives the voters of an opportunity to hear the candidates' responses to voters' questions, and deprives their opponents of an opportunity to present their positions to the voters in a fair and equal space.

Fortunately, voters can compare candidates side-by-side and read their views on important issues in their own words on **VOTE411.org**, the League of Women Voters' premiere website for election information.

We would certainly welcome whatever assistance WCLO could give for promoting attendance in the forums. If you think you would be interested in recording the Rock County Sheriff's forum, I believe we would need to get the approval of JATV.

If you have questions for the candidates that you would like to submit, we welcome them. We're setting up a web-based form for area residents to submit questions for candidates running for Rock County Sheriff. I'll be sure to send you the link.

**If YOU are more successful in gaining the cooperation of all the candidates than we have been, we would certainly do what we can to encourage our members and the general public to tune in to your live and taped broadcasts.**

The forum committee is in the process of drafting a "letter to the editor" expressing our disappointment that so many of the candidates were unwilling to cooperate with our organizations. Accomplishing the League of Women Voters' mission "Empowering Voters. Defending Democracy" is made more difficult when candidates for office deny voters opportunities to learn their positions.

We're looking forward to having more (and better?) opportunities to work with you.

# Youth Engagement in the Democratic Process

At our state LWV convention this year, four young women from Wisconsin participated on a panel discussion entitled, "Youth Engagement in the Democratic Process." Madeleine McDermott, of Bellevue (near Green Bay), has dedicated the last three years of their life to creating change in their community. They began organizing with the "Fridays for Future" movement, and continue to fight for a sustainable future as a Clean Energy Fellow with the Wisconsin Conservation Voters. Mandeep Kaleka is a former Youth Governor of Wisconsin and intern at the Outagamie County District Attorney's office. Next year, she will be attending the University of Wisconsin-Madison, where she is planning on double majoring in political science and international business. Ivy Evrard is the Vice President of the Political Science club at the University of Wisconsin Oshkosh Fox-Cities campus. She has taken an active role in organizing voter registration drives on campus, and is currently pursuing a degree in political science. Eeshani Buddi is a freshman at Carleton College (MN), and intends to major in biology. She has participated in both Wisconsin Youth In Government, and has been a Diversity Intern for the City of Appleton.

Jeanne Roberts, Community Alliances Committee co-chair, LWV Appleton-Fox Cities, served as moderator for the discussion, and asked each one several questions about how current League members can better reach out to the young people in their local communities. McDermott talked about reaching out to young people "where they are." If they are in school, go to the schools. If they are attending personal interest clubs, reach them there. "Reach out to them through music and art. Have meetings at times when young people can attend." After all, they can't attend meetings during the day when they are in school.

Kaleka emphasized that there are plenty of young people out in their communities who are already organizing and organized with various issues. Join with them! Many are passionate about social issues of today, but they don't know how to sustain their momentum. They need help with translating their passion into concrete measures that make a difference. Adult mentors could teach them how to connect their passion with regular democratic processes, so their actions will be sustained and lead to something.

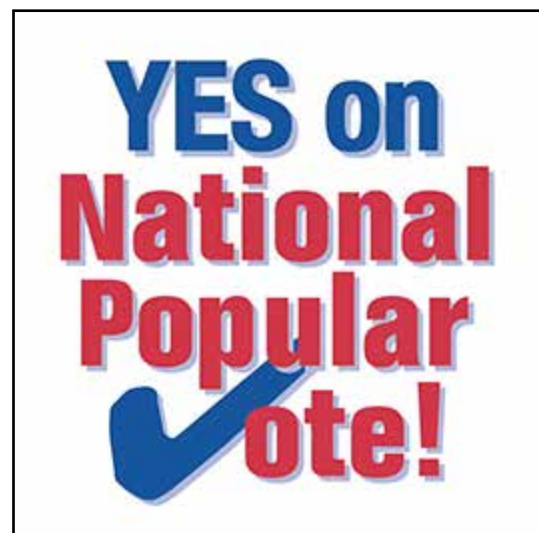
Evrard, too, emphasized that young people, "ARE out there." Have them present at your local functions! Reach out to them at local universities and other post-secondary institutions. Young people in Appleton, who are interested in promoting social change, tend to hang out in Houdini Plaza. It's wise to go to these places, and get to know them. Gen Zers are doing much activism right now, but they do need someone to teach them the importance of voting! Teach them how to regis-

ter, and where to vote! Observe who is being active, and use them in your league work. She is passionate about working for systematic change to take place, especially in the area of environmental justice, and climate change.

Buddi credits her mom in teaching her how to be civically-engaged, and with learning how important it is to vote. Much like the others, Buddi too, pointed out that young people are already organizing themselves around various issues, and interests. We need to just reach out to them where they are! In terms of the question of how current members can become more relevant to young people, she advised them to be present and visible in the schools, so young people can see who they are and what the league is doing to inform voters. Current league members need to inform themselves of what young people are already doing politically. Get to know them, and help the activists you already know.

Kaleka noted how closely tied her generation is to technology. They've especially been using it even more during the COVID pandemic. Kaleka and Buddi both talked about how important it would be for current league members to follow young people on social media. In this way, we can all get to know one another better. Young people would then be more open to learning what the League has to teach them. Trust among the generations would have the opportunity to develop on social media. The League could even be sending out mass emails to students in schools, and universities.

In addition, the young women suggested that state and local Leagues should offer more internships for young people, both unpaid, or minimally paid. They want to learn from us, not only how to vote, but how to run for office! To sum it all up, more league members need to be more directly, and actively involved with young people, and serve as mentors to them. Young people are looking for it!

Welcome, welcome, welcome to our new members! It is great to see the League's growth these last few months!

Voter Services has been working this summer through the primary and towards the midterm elections!

### Candidate Forums

One of our projects has been working on co-hosting candidate forums with the Beloit, Whitewater, Dane County Leagues and the Beloit NAACP #3251. The committee planned eight forums county-wide forums but will host only three. Regrettably, the other five forums had to be cancelled because only one of the candidates running, in each of those races, agreed to participate. The Leagues and NAACP are forwarding a joint letter to the editor on the outcome of our planning with and a statement thanking those that have accepted the invitations as well as a statement of our policy of not holding "empty chair forums". The letter explains that proceeding with only one candidate would give an unfair advantage to the sole participating candidate, risking the League's compliance with FEC and or IRS rules as well as the League's nonpartisan policy.

### The three scheduled forums that will take place are:

Rock County Sheriff – Wednesday, September 28 – 6:00 to 7:30 p.m. hosted at Hedberg Library Live Stream and record by JATV

Assembly District 33 Thursday October 6 - 6:00 p.m. to 7:30 p.m. hosted at the Dwight Forster Public Library, Fort Atkinson, filmed by Whitewater Community TV

Assembly District 45 Wednesday October 12, 6:00 to 7:30 p.m. hosted in the School Board Room, School District of Beloit. Video recorded.

Email requests will be sent to invite our member to assist at these forums in various capacities. This is a great opportunity to meet the candidates as well as other area League members and see firsthand how our forums are conducted. We will need several volunteers and hope everyone will consider working at a forum.

## **In the planning stages:**

We are also working with the local high schools and charter schools and U-Rock scheduling Voter Services Days at each of their campuses now until the on-line registration deadline of October 19.

We are working with local churches, YWCA and the Job Service offices to share Voter Registration/Are You Ready to Vote materials electronically and with in person staff training on the “how tos”.

Overall, at each of these events, there are loads of questions from voters. There have been so many

changes in polling places, the redistricting and changes in election rules, etc. that there have been a lot of things to discuss and continue to discuss!!

We have been reminding them where and how to verify their registration, polling places etc through on-line resources or phone numbers for the City or County Clerk’s offices.

We are using a “buddy system for new members, pairing new members with current members and have some “Voter Services Scripts” suggestions. We may not have to have all the answers at these events, but we do focus or identify the questions and provide the information on how the voter may contact their City Clerk for further information and clarification.

We are very fortunate to be supplied effective LWV branded handouts, Vote 411 pens to use at our events. The LWV branded materials are quality handouts and make the Voter Services event process very painless and a breeze!

## **Door Hangers Projects**

Thank you to those members that have been participating in this project!

We have also received from the National LWV primary and election door hangers – which remind voters of the either the primary date or election date, and list online resources for registration, vote411.org and Voter Helpline phone number. In late July, we had formed a committee and hung 500+ door hangers

We have 2000 more for the General Election on November 8.

A signup email will be sent out to plan and schedule for our next project in October. The hangers are well made and provide good reminders of our resources available and a reminder of the dates of the primary or general election.
