Dear Friends in League,

Although the temperatures are still low, the day-light hours are getting longer, and we turn ourselves to thoughts of Spring. For League mem-

bers that means Spring Elections on Tuesday, April 2 and all that goes into preparing for them.

- There is a very important statewide election for a Justice of the Wisconsin State Supreme Court on the ballot in addition to local elections.
- The Voter Services Committee needs additional volunteers to help newly eligible voters in our area high schools, colleges and other locations register to vote. You may also know of voters who have moved recently who need to update their registration. The deadline for online voter registration (OVR) at http://myvote.wi.gov is March 13.
- Remember that all voters in Wisconsin can request an absentee ballot be mailed to them for any reason.
- The LWV of Janesville, with partners Forward Janesville and JATV, will conduct a City Council Candidates Forum on **Tuesday, March 12, 6:30-8:00 pm** at the Hedberg Public Library. You will be able to find a link to JATV's webcast of that forum on our website when it become available.
- Candidates for the Janesville School Board have provided written responses to questions posed by the

At that meeting we can also vote to initiate study toward developing a new local position, with the understanding that any local position our League develops must be based on and be consistent with positions that have been taken by LWVUS and LWVWI that you can find on their websites. I am confident that reviewing these positions will make you feel proud that you are a member of this organization.

sense of where they stand in relation to others. Feeling poor matters—not just being poor. Regardless of their average incomes, countries or states with greater levels of income inequality have much higher rates of all the social maladies we associate with poverty, including lower than average life expectancies, serious health problems, mental illness, and crime."

People on the lower rungs of the ladder have little trust in investing for the future. Poverty increases stress. He also cites studies that offer explanations of how people's perception of their social status affects their political beliefs and leads to greater political divisions, something we've all pondered since the 2016 election. Economic anxieties also fuel racial conflict.

One chapter examines inequality between blacks and whites and tries to explain why our police are prone to overreact in their interactions with black males... seeing weapons where there were none: "police are

programmed to see danger."

While I was somewhat aware of the social comparisons that we make daily, I was unaware of how deeply those unconscious thoughts guide our behaviors. Interesting, depressing, and sometimes tiring in forcing the reader to focus hard to understand the meaning(s) of the experiments' results, the book does end on a hopeful note: "We can, in fact, exert more control over how we compare. Controlled comparison means, first, learning to recognize when we are in the grips of such a compulsion, and, second, choosing wisely what kind of comparison is really relevant and useful. The idea here is not to stop comparing; it is to compare more wisely....The point is not to compare with the winners (upper rungs of the ladder), or to compare with the losers (bottom rungs of the ladder). It is to compare, with lucidity. (In different circumstances, that might be me.)
